## TE ANGA RAUTAKI A HERITAGE NEW ZEALAND POUHERE TAONGA

### TIROHANGA WHĀNUI

Ka whakatakoto tā mātou Tauākī o Ngā Tūmanakohanga Whakatutuki 2021-22 i tō mātou kitenga, ō mātou whāinga tōmua matua i te tau pūtea 2021-22, te pānga o ēnei ki ngā whāinga tōmua o te Rāngai Toi, Ahurea, Taonga Tuku Iho hoki, ā, ka pēhea e whakamātau ai i ā mātou mahi.

### TŌ MĀTOU KAUPAPA MATUA

Ko te kaupapa o te Heritage New Zealand Pouhere Taonga Act 2014 ('te Ture') ko te whakatairanga i te tauhutanga, te tiakinga, te rokiroki me te penapena i ngā taonga ingoa-nui, taonga ahurea hoki o Aotearoa. I whakatūria a Heritage New Zealand Pouhere Taonga hei whakatutuki i taua whāinga.

Kei te Ture he ritenga kia whai whakaaro, kia whakaute hoki i te haepapa mō te Karauna, ki te whakatinana i te Treaty of Waitangi/Te Tiriti o Waitangi.

### KO TE RŌPŪ MATUA MŌ NGĀ TUKUNGA IHO KĀKANO RUA O AOTEAROA<sup>1</sup>

E mahi ana kia whakatutuki ai te whāinga ā-ture me ngā mātāpono o te Ture, ko Te Pouhere Taonga te tari arataki mō ngā take tukunga iho kākano rua o ngā wāhi tuku iho. Hau noa tōna rongo kei Aotearoa nei, kei tāwāhi hoki mō ngā whakahere kākano rua mō ngā take tukunga iho, te penapena, te whakatakoto ritenga mō ngā wāhi mātai whaipara, te whakaputa tuhinga, te whakawhitihiti hoki o ngā kōrero tuku iho o Aotearoa New Zealand – ngā tini take atu anō hoki. Hei rōpū kaha ki te whakatutuki, kia tūturu tonu mātou ki ā mātou whakatutikitanga. Otirā, ko te tūmanako, kia pikī tonu tō mātou kaha ki te whakatutuki i ngā mea angitū, hei whai hua mō ngā tāngata katoa o Aotearoa mē ō tātou tukunga iho.

## HERITAGE NEW ZEALAND POUHERE TAONGA STRATEGIC FRAMEWORK

### OVERVIEW

Our Statement of Performance Expectations sets out our vision, mission and key priorities for our activity in the 2021-22 financial year, how these relate to the priorities of the Arts, Culture and Heritage Sector, and how our māhi will be assessed.

### OUR PURPOSE

The purpose of the Heritage New Zealand Pouhere Taonga Act 2014 ('the Act') is to promote the identification, protection, preservation and conservation of the historical and cultural heritage of New Zealand. Heritage New Zealand Pouhere Taonga is established to give effect to that purpose.

The Act includes provisions to recognise and respect the Crown's responsibility to give effect to the Treaty of Waitangi/Te Tiriti o Waitangi.

### NEW ZEALAND'S LEADING BICULTURAL HERITAGE ORGANISATION<sup>1</sup>

Working to achieve the purpose and principles of the Act, Heritage New Zealand Pouhere Taonga is the lead national bicultural heritage agency for heritage places. It has an outstanding record in New Zealand and internationally for bicultural heritage management and conservation, archaeological site regulation, publications, statutory advocacy, and communication of the heritage stories of Aotearoa New Zealand – and much else. As a high-performing organisation, we hold fast to all of our achievements. At the same time, we aspire to be even more effective, realising future opportunities to make a difference for all New Zealanders and our heritage.

In this Statement of Performance Expectations we focus more strongly than ever before on ensuring that Māori heritage and te ao Māori are prominent in all that we do.

We promote our purpose by characterising it with an expression of New Zealand's cultural heritage, the whakataukī:

#### VISION

Tairangahia a tua whakarere;  
Tātakihia ngā reanga o āmuri ake nei  
Honouring the past; Inspiring our future

Heritage New Zealand Pouhere Taonga achieves this through:

#### MĀORI HERITAGE

- supporting iwi and hapū with built heritage conservation projects;
- supporting post-settlement outcomes pertaining to heritage;

#### HERITAGE IDENTIFICATION

- maintaining the New Zealand Heritage List/Rārangi Kōrero;
- providing heritage assessments of Crown property to be disposed of, and making recommendations for heritage protection on such land;
- supporting owners to identify and reduce risk to National Historic Landmarks/Ngā Manawhenua o Aotearoa me ūnā Kōrero Tūturu;

#### ARCHAEOLOGICAL REGULATION

- administering the regulation of archaeological resources through the archaeological authority process;
- making reports available about New Zealand's archaeological resources;

- te whakahaere me te whakauka i ngā whenua 45 (40 e huaki ana ki te iwi nui tonu, 21 o ēnei e whakahaeretia e ngā kaimahi hei ūnga ingoa-nui mō te manuhiri);

**TE TOHUTOHU ME TE HAPAHAPAI**

Ā ngā tau 2021-22, tae ana ngā whai wāhitanga e hiahia ana mātou ki te:

- tū hei whakahaere matua mō ngā tukunga iho kākano rua o Aotearoa;
- whakatairanga i ngā taonga tuku iho me ngā uara Māori, i roto i ā mātou mahi katoa;
- te whakarere kōrero atu anō mō ngā tukunga iho me ngā wāhi ahurea Māori ki te marea o Aotearoa e kaha haere ana tō rātou hiahia me tō rātou aro ki te ao Māori, ki te ako i te reo Māori hoki;
- te ārahi i te arotahi o ngā tāngata o Aotearoa ki ā rātou ake kōrero tuakiri mā te kaupapa o Ngā Tohu Whenua me ngā National Historic Landmarks/Ngā Manawhenua o Aotearoa me ūna Kōrero Tūturu i tēnei wā e ākina ana ngā tāngata katoa o Aotearoa e te urutā Covid-19 kia aro anō ki tō rātou ake whenua;
- te hāpāi i te mana o ngā taonga tuku iho i roto i te anga ture mā te arotake i te Resource Management Act me te arotake i te tiakitanga taonga tuku iho; ā,
- whakatauria i te whāomoomo me te whakakaha i ngā whare kōhatu i tā tātou mahi ki te Whare Kāwanatanga o Hokitika, ā, ki te tau mai te pūtea tautoko, te Whare o Turnbull, ki Pōneke.

Arā noa atu te maha o ngā whai wāhitanga ka puta i te roanga o te tau. Ka haere tonu tā mātou mahi arotake, ā, ka whai rautaki ina ka kapo whai wāhitanga e tino pai rawa atu ai te whakatutuki kitenga: Honouring the past; inspiring the future - Tairangahia a tua whakarere; Tātakihia ngā reanga o āmuri ake nei.

**HERITAGE PROPERTY MANAGEMENT**

- maintaining and conserving 45 properties (40 open to the public, with 21 of these operating as staffed visitor attractions);

**ADVISING AND ADVOCATING**

- working with local authorities on identifying historic heritage in plans, promoting its protection with appropriate rules, monitoring plan quality, and promoting protection through resource consent processes;
- administering the National Heritage Preservation Incentive Fund;
- providing advice to the owners of heritage places, including local authorities and iwi/hapū;
- maintaining and developing an active support network, including organisational membership;
- engaging people in a range of events around the country about New Zealand's outstanding cultural and historical heritage; and
- building a collaborative framework for New Zealand's heritage based on realising its enormous potential to contribute to education, skills development and employment.

**GOVERNMENT PRIORITIES**

Each of the Government's priorities for the Arts, Culture and Heritage Sector, set out below, inform the Heritage New Zealand Pouhere Taonga strategic priorities:

- All New Zealanders can access and participate in cultural experiences;
- The cultural sector is supported and growing sustainably; and
- New Zealanders share a distinct and inclusive identity and value our history and traditions.

We help to deliver these priorities, both independently and working with others, as indicated in our performance measures (see Section 3: Heritage New Zealand Pouhere Taonga Key Priority Outputs 2021-22) and as set out below.

**OUR MISSION**

All our work is directed towards achieving our mission through our delivery and advocacy priorities.

**MISSION**

*Ensure that our bicultural history is understood by New Zealanders and all peoples*

*Ko te pae tawhiti, whāia kia tata; ko te pae tata, whakamaua kia tina.*

*Seek you the distant horizon to bring it close, the horizon that is close hold fast.*

In 2021-22, the opportunities we seek to bring close include:

- being New Zealand's leading bicultural heritage organisation;
- giving prominence to Māori heritage and values in all our work;
- telling more stories about Māori heritage and cultural landscapes to a New Zealand public that is ever more receptive to engaging with te ao Māori and to learning te reo Māori;
- focusing New Zealanders' attention on their own identity stories through Tohu Whenua and the National Historic Landmarks/Ngā Manawhenua o Aotearoa me ūna Kōrero Tūturu programme at a time when the Covid-19 pandemic compels all New Zealanders to re-engage with their own country;
- improving the place of heritage in the statutory framework through the review of the Resource Management Act and the heritage protection review; and
- leading by example in the conservation and strengthening of earthquake-prone masonry buildings in our work on the Hokitika Government Building and, subject to funding, Turnbull House, Wellington.

Many other opportunities will arise throughout the year. We will continue to evaluate them, and to take a strategic approach to seizing those opportunities that best achieve our vision: Tairangahia a tua whakarere; Tātakihia ngā reanga o āmuri ake nei – honouring the past; inspiring the future.

Ka arahina mātou e ō mātou whāinga tōmua mō te hora ratonga me te tohutohu, mō ā mātou whāinga matua *rautaki* e whā. Kua tipu mai ēnei i ngā whāinga rautaki matua i tā mātou Tauāki Whakamaunga Atu (SOI) 2020-2024<sup>2</sup> kia whāiti nei te arotahi ki:

- ngā hononga, inarā, ko ngā hononga ki te tangata whenua
- te whakawhanake i te whakapono me te māia ki te whakaora me te tiaki i ngā wāhi tuku iho hira me ngā whaitua ā-ahurea.

## HERITAGE NEW ZEALAND POUHERE TAONGA PRIORITIES

In operationalising all of our māhi, we have two guiding priorities:

Deliver effectively against all our statutory requirements and processes.	Influencing and understanding the priorities and actions of other organisations.

Guided by our delivery and advisory priorities, we have four *strategic* priorities. These have evolved from the strategic priorities in our 2020-2024 Statement of Intent<sup>2</sup> so as to sharpen our focus on:

- relationships, particularly with tangata whenua;
- building trust and confidence in conserving and protecting important heritage places and cultural landscapes.

All of our strategic priorities are informed by *Tapuwae, Nā te Kaunihera Māori mō te Pouhere Taonga Māori: The Māori Heritage Council Statement on Māori Heritage*.<sup>3</sup>

### STRATEGIC PRIORITIES

- Strengthening relationships and understanding the priorities of others, particularly Tangata Whenua;
- To conserve and protect important heritage places and cultural landscapes;
- To build trust and confidence of those who we work with; and
- To lead as an innovative and effective organisation.

## NGĀ HUA RAUTAKI

Ko te whakarāpopoto i ā mātou hua rautaki, me te hono ki tō mātou anga ine (ngā KPI), ka pēnei:

### NGĀ HUA RAUTAKI – NGĀ TUKUNGA IHO MĀORI

Tukuna he tukanga whakapāpā, ki Tangata Whenua mā rātou hoki – tae ana ki te horanga o ngā rangahau ā-tau, te whakawhanake i tētahi mahere tuku, mahere whakapāpā hoki, me te tukunga hei whakatutuki i aua kawatau i maheretia ai.

Ka waihanga, ka mahi tahi hoki me ngā rōpū kē – tae atu ki Te Puni Kōkiri, Manatū Taonga Ministry for Culture and Heritage, Te Arawhiti, ngā rōpū o te Ara Taonga me ngā tāngata ngaio o te rāngai taonga tuku iho, tae atu ki ngā hononga, te rite tonu o te kōrerorero me ngā mahere horanga mahi tahī.

Kia hora i te penapena taonga Māori tuku iho kia āhei ai te Kaitiakitanga – tae atu ki te tautoko i te whakawhanake i te whakapāpātanga ki te rāngai ngaio Māori (mātai whaipara, whakarauora, ngā mahi toi tuku iho) me te horahanga i ngā ara tohutohu e tuku ana i te ngaiotanga whakaroto, te tohutohu me ngā tikanga pai rawa.

## OTHER DELIVERABLES BY CONTRACT

### MĀTAURANGA MĀORI TE AWE KŌTUKU PROGRAMME

At the heart of our strategic deliverables in 2021-22, and in the following financial year, is our Mātauranga Māori Te Awe Kōtuku programme. This programme has two work streams that will:

- revitalise vulnerable Mātauranga Māori in ancestral landscapes; and
- revitalise built heritage conservation mātauranga and practices.

The ancestral landscapes work stream will focus on joint programmes (with iwi, hapū, marae hapori, tohunga, pūkenga and kaitiaki) to support and revitalise vulnerable landscapes, wāhi tapu and wāhi tūpuna mātauranga. It will involve mapping, pūkenga-led wānanga, pūrākau and pakwaitara, māhinga kai practices, and much else. The built heritage work stream will focus on joint projects to support and revitalise hanga whare mātauranga and practice (traditional arts and whare building construction and joinery), tārai waka, māhinga kai and māra kai.

In 2021-22, this initiative will be delivered through pouhere mātauranga wānanga which will consolidate existing mātauranga and enable co-design of practice wānanga. Most of the practice wānanga will be held in following years. As part of this initiative, we will also administer contestable funds to iwi/hapū-led projects that further support and protect aspects of Mātauranga Māori.

Overall, this initiative will have a profound and lasting impact on Mātauranga Māori, and on New Zealand identity more widely. We will work with Manatū Taonga, the Ministry for Culture and Heritage, to further develop and implement an evaluation framework to report on its outcomes.<sup>5</sup>

At the same time, we will continue our existing programmes of delivering Māori heritage conservation to enable Kaitiakitanga. Through all this work we establish pathways for others to follow – building knowledge of conservation practice, offering in-house expertise and advice, and modelling best practice. We will have a particular focus on working with others to enable Māori to become part of the professional sector.

### HOKITIKA GOVERNMENT BUILDING UPGRADE

In 2020-21, the Government appropriated \$22 million in Vote Arts, Culture and Heritage for the purchase and upgrading of the Hokitika Government Buildings (also known as Seddon House) as a Covid-19 recovery project. Heritage New Zealand Pouhere Taonga was delighted to accept responsibility for this project and last year purchased the building with some of the above funds. Initial investigative work for this project is nearing completion, and in the 2021-22 financial year we will deliver a full project plan for the extensive strengthening and upgrading works that are required. The ultimate outcome will be the preservation and re-use of this impressive Category 1 historic place that forms an integral part of the Hokitika Tohu Whenua.

## HERITAGE NEW ZEALAND POUHERE TAONGA KEY PRIORITY OUTPUTS 2021-22

The Heritage New Zealand Pouhere Taonga outputs are in the Crown appropriation 'Management of Historic Places', and are for the 'identification, protection, preservation, and conservation of the historical and cultural heritage of New Zealand'.

Our two special projects (our Mātauranga Māori Te Awe Kōtuku programme and Hokitika Government Buildings) are funded through separate Covid-19 recovery-related contracts, managed by Manatū Taonga, the Ministry for Culture and Heritage. While not part of the reporting framework established by this Statement of Performance Expectations, we include a summary of the reporting measures for these projects (on page 19), to provide a fuller data picture of our organisational performance.

### COVID-19

The impacts of Covid-19 remain a live concern in measuring all our KPIs.

In 2019-20, we reviewed our KPIs, and established baselines for a range of measures, especially by collecting more finely grained data on who is accessing our services and products. The disaggregated data enables us to better evaluate our reach into New Zealand communities.

However, this level of reporting presents some challenges in a Covid-19 environment. As noted, in 2019-20 we were unable to develop baselines on visitor experiences at our properties, as the survey through which we were to collect this data (the

Museums Aotearoa survey) was adversely affected by the Covid-19 pandemic.

We faced similar challenges in 2020-21, with the dates of our Museums Aotearoa survey coinciding with the imposition overnight of Alert Level 3 in Auckland and Alert Level 2 in the rest of the country. The net result was that our survey period was cut short, reducing the numbers of visitors surveyed. We will nonetheless establish a baseline using the data we were able to collect, although we caution that the quality of reporting and our results generally remain vulnerable to the ongoing, though decreasing, impacts of the Covid-19 pandemic.

# MATAPAE TAUĀKĪ PŪTEA 2021-22

## PROSPECTIVE FINANCIAL STATEMENTS 2021-22

### NGĀ MATAPAE WHAKAMAHERE PŪTEA

#### FINANCIAL PLANNING ASSUMPTIONS

Heritage New Zealand Pouhere Taonga has forecast total income for 2021-22 as \$23.9 million. This comprises \$17.6 million from the Crown and \$6.3 million from the Heritage New Zealand Pouhere Taonga membership base, properties, grants and other income.

During the 2021-22 year, Heritage New Zealand Pouhere Taonga will focus on retaining its core capability, and further resetting and rebuilding the revenue generating elements of its business (cafés, shops, museums and membership). As demand for our services exceeds our capacity to supply, Heritage New Zealand Pouhere Taonga welcomes the addition to its baseline of \$1.5 million approved in Budget 2020, and the additional appropriations of \$1 million for our Mātauranga Māori programme, and \$10 million for the strengthening and refurbishment of the Hokitika Government Buildings (formerly known as Seddon House).

In 2020-2021 we completed the refurbishment of Kate Sheppard House as a visitor attraction and function centre. We also purchased the Hokitika Government Buildings on behalf of the Crown and undertook a series of critical tests on this new property, including testing it for asbestos and lead paint, and doing a Geotech assessment of the land it sits on. A major expenditure focus for 2021-22 will be putting into action the project plan for Hokitika Government Building's strengthening and repair. We will also be fundraising to re-roof Antrim House and subject to funds raised will proceed with this project as well. We have continued with the significant reduction in our allocation for capital expenditure in order to ensure the maintenance of our operational capability. While we are focused on developing non-Crown revenue streams, it has become clear that the requirements of maintaining our portfolio are likely to necessitate a bid for capital funding in Budget 2022 and, in accordance with our Letter of Expectations we will share our long-term capital plan for the conservation works and maintenance that the portfolio requires.

These statements include the financial transactions and balances of the Canterbury Earthquake Heritage Building Trust, which is controlled by Heritage New Zealand Pouhere Taonga.

#### SIGNIFICANT ASSUMPTIONS RELATING TO THE IMPACT OF COVID-19

The prospective financial statements assume that the current Alert Level 1 status will remain in place and that visitors from the international community beyond Australia and the Pacific Islands will not resume in 2021-22. Property and membership income remains diminished compared with pre-Covid-19 levels, but local support has been stronger than previously forecast and this more robust response is incorporated in the forecast. However, the impacts in the wider international community, and their longer-term toll on the domestic economy, remain uncertain as does the potential for a return to higher alert levels, and this is an important note of caution for our estimates for this income.

#### OTHER SIGNIFICANT ASSUMPTIONS

- Outcomes sought by the Government remain consistent. Heritage New Zealand Pouhere Taonga will continue to provide leadership as the Government's adviser on the care and protection of New Zealand's heritage;
- The functions of Heritage New Zealand Pouhere Taonga have been increased via contracts to operate a Mātauranga Māori programme and strengthen and refurbish the Hokitika Government Buildings – the level of activity in all functions will continue to be prioritised to maximise the outcomes for heritage;
- While maintaining delivery of core services in other output classes, there will be continued focus on delivering key projects at a selected number of properties within the Heritage New Zealand Pouhere Taonga portfolio, such as Antrim House;
- It will be possible to proceed with the strengthening and refurbishment of the Hokitika Government Buildings without disruption to construction supplies and services;
- We will proceed with the earthquake strengthening and refurbishment of Turnbull House only if appropriated to do so in Budget 2021;
- As a continuation of the Property Rationalisation Project, it is possible there may be changes to the Heritage New Zealand Pouhere Taonga property portfolio during the 2021-22 financial year. However, no provision has been made for this in the financial statements;
- While there is to be a revaluation of the property portfolio, no significant changes have been allowed for in the valuation of the properties or collections;
- Insurance costs remain static and we have continued our partial self-insurance model;
- Interest rates for 2021-22 will remain below 1%;
- Due to high demand for its services, and as set out in the Letter of Expectations, Heritage New Zealand Pouhere Taonga will continue its efforts to grow non-government revenue sources and opportunities to collaborate with other agencies to maximise the impact of Heritage New Zealand Pouhere Taonga initiatives. These will include accessing grants and donations to fund major capital projects;
- Heritage New Zealand Pouhere Taonga will continue to manage the Tohu Whenua programme that promotes heritage places to visitors. The budget of \$390,000 for this activity is funded equally by Heritage New Zealand Pouhere Taonga, Te Papa Atawhai Department of Conservation and Manatu Taonga Ministry of Culture and Heritage; and
- Heritage New Zealand Pouhere Taonga will continue to develop its systems to enable the progression of its IT services from Infrastructure-as-a-Service to Cloud-based services.

## PROSPECTIVE STATEMENT OF ACCOUNTING POLICIES

### REPORTING ENTITY

Heritage New Zealand Pouhere Taonga is a statutory body corporate established under section 9 of the Heritage New Zealand Pouhere Taonga Act 2014 and domiciled in New Zealand. It is an Autonomous Crown Entity for the purposes of section 7 of the Crown Entities Act 2004 and its ultimate parent is the New Zealand Government.

Heritage New Zealand Pouhere Taonga's registered office is at Antrim House, 63 Boulcott Street, Wellington.

The Group includes the Canterbury Earthquake Heritage Buildings Trust, which is controlled and managed by Heritage New Zealand Pouhere Taonga. The Trust was established on 1 July 2016 to continue the functions of the Canterbury Earthquake Heritage Buildings Fund, which were transferred to Heritage New Zealand Pouhere Taonga in May 2014 and ceased operating on 30 June 2017 due to a sunset clause in its original deed.

Heritage New Zealand Pouhere Taonga's primary outcome is to ensure present and future generations of New Zealanders experience and enjoy a sense of place, identity and nationhood. Accordingly, Heritage New Zealand Pouhere Taonga (as the parent) and its subsidiary have designated themselves as Public Benefit Entities (PBEs) for financial reporting purposes.

These prospective financial statements for Heritage New Zealand Pouhere Taonga are for the year ended 30 June 2022, and were approved by the Board on 30 June 2021.

### BASIS OF PREPARATION

The financial statements are prepared on the basis that Heritage New Zealand Pouhere Taonga continues to be a going concern. Accounting policies have been applied consistently throughout the year.

### Statement of compliance

The financial statements have been prepared in accordance with the requirements of the Crown Entities Act 2004, which includes the requirement to comply with New Zealand generally accepted accounting practice (NZ GAAP).

The financial statements have been prepared in accordance with the PBE Standards Reduced Disclosure Regime (RDR). The criteria under which an entity is eligible to report in accordance with PBE Standards RDR are the entity is not publicly accountable and has expenses less than \$30 million.

### Measurement base

The financial statements have been prepared on an historical cost basis, modified by the revaluation of certain property, plant and equipment.

### Presentation currency and rounding

The financial statements are presented in New Zealand dollars and all numbers are rounded to the nearest thousand dollars (\$000s).

### Prospective figures

Accounting policies applied to these prospective financial statements are consistent with the accounting policies adopted by the Board for the preparation of Heritage New Zealand Pouhere Taonga's Annual Financial Statements.

Actual results achieved for the period covered are likely to vary from the information presented and these variations may be material.

### ACCOUNTING JUDGEMENTS AND MAJOR SOURCES OF ESTIMATION UNCERTAINTY

In the application of Heritage New Zealand Pouhere Taonga's accounting policies, the Board is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

Estimates and assumptions in relation to the valuation of heritage land, buildings and improvements are a significant risk of causing material adjustments to the carrying amounts of assets.

Management has also exercised critical judgement in the application of accounting policies in relation to grant and bequest income, grant expenditure, and the recognition of assets over which Heritage New Zealand Pouhere Taonga has management and control.

### Controlled and managed buildings

Properties for which Heritage New Zealand Pouhere Taonga has a control and management order under the Reserves Act 1977 have been included as part of property, plant and equipment on the basis that the risks and rewards relating to this property rest with Heritage New Zealand Pouhere Taonga.

### Major sources of estimation uncertainty

The continued impact of the global Covid-19 pandemic on domestic and international visitor numbers is uncertain and likely to have an effect on membership and property revenue. Management assumptions in relation to Covid-19 are noted in the financial planning assumptions preceding the financial statements.

The valuation of historical land and buildings is subject to considerable estimation uncertainty. Heritage New Zealand Pouhere Taonga employs an independent valuer to revalue Heritage New Zealand Pouhere Taonga's property portfolio in line with the Crown

accounting policies and Treasury requirements. Valuations are undertaken at least every three years to ensure that the carrying amount does not differ materially from fair value. However, due to the nature of Heritage New Zealand Pouhere Taonga property portfolio, it is difficult to obtain market valuation comparisons for many properties due to restrictions on their use.<sup>22</sup> Consequently there is a large degree of subjectivity inherent in the valuation process.

The following are the key assumptions concerning the future, and other major sources of estimation uncertainty used in the development of these prospective financial statements:

- The valuation of historic buildings includes an estimation of the residual values and useful lives. These estimates impact on the depreciated replacement cost and annual depreciation charges for historic buildings. The estimated useful lives are detailed in the depreciation accounting policy.
- The valuation of buildings also includes estimations of construction costs.

#### SIGNIFICANT ACCOUNTING POLICIES

The following accounting policies that materially affect the measurement of prospective financial performance and prospective financial position have been applied:

##### *Basis of group*

The financial statements of the Canterbury Earthquake Heritage Buildings Trust are prepared for the same reporting period as the parent company, using consistent accounting policies. There are no transactions between the parent and its subsidiary.

##### *Goods and Services Tax (GST)*

All items in the financial statements are exclusive of GST with the exception of trade and other receivables and trade and other payables, which are stated inclusive of GST. Where GST is not recoverable as input tax then it is recognised as part of the related asset or expense.

The net amount of GST recoverable from, or payable to, the Inland Revenue Department (IRD) is included as part of the receivables or payables in the Statement of Financial Position.

##### *Income tax*

Heritage New Zealand Pouhere Taonga is a public authority and consequently is exempt from the payment of income tax. Accordingly, no charge for income tax has been provided for.

##### *Revenue*

Revenue is measured at the fair value of consideration received or receivable.

#### *Revenue from the Crown*

Heritage New Zealand Pouhere Taonga is funded by the Crown for the purposes set out in the Act and the Vote Arts Culture and Heritage appropriations as set out in its Statement of Intent.

As there are no conditions attached to the funding outside of these purposes it is recognised as revenue at the point of entitlement.

#### *Donations and bequests*

Donations and bequests received are recognised as revenue in the period they are received. However, those with restrictive conditions are recorded as Specified Funds and Bequests within equity.

#### *Grants received*

Grants are recognised when they become receivable unless there is an obligation to return the funds if conditions of the grant are not met. Where such an obligation exists, the grants are initially recorded as grants received in advance and recognised when conditions of the grant are satisfied.

#### *Vested assets*

Where a physical asset is gifted or acquired by Heritage New Zealand Pouhere Taonga for nil or nominal cost, the fair value of the asset is recognised as income when control over the asset is obtained.

#### *Volunteer services*

The operations of Heritage New Zealand Pouhere Taonga are reliant on services provided by volunteers. Volunteer services received are not recognised as revenue or expenditure by Heritage New Zealand Pouhere Taonga due to the difficulty of measuring their fair value with reliability.

#### *Membership subscriptions*

Membership subscriptions are recognised in the period received.

#### *Interest*

Interest income is recognised using the effective interest method.

#### *Merchandise and café sales*

Revenue from merchandise and café's sales is recognised when the product is sold to the customer.

#### *Function and event revenue*

Revenue from functions and events is recognised at the date the function or event takes place.

#### *Lease and rental income*

Lease and rental income is recognised on a straight-line basis over the lease term.

#### **COST ALLOCATION TO OUTPUTS**

Direct costs are charged directly to specific outputs. Indirect costs are allocated across outputs based on an estimate of effort determined by management. Direct costs are those costs directly attributable to a specific significant activity and Indirect costs are costs incurred that cannot practicably be attributed to a specific significant activity.

There has been no change to the cost allocation methodology since the date of the last audited financial statements.

#### **GRANT EXPENDITURE**

The Incentive Fund and other grants awarded by Heritage New Zealand Pouhere Taonga and its subsidiary are discretionary grants. Discretionary grants are those grants where Heritage New Zealand Pouhere Taonga has no obligation to award on receipt of the grant application.

Grants are approved subject to conditions and uplifted only when those conditions have been satisfied. Approved grants are recognised as expenditure and held as an expense provision until they are lifted by the grantee. Where there is doubt that the conditions of a grant will be met, the provision will be reversed until there is confidence that the terms of the grant are likely to be satisfied. If it is determined that all or part of a grant will not be uplifted, the grant is returned to the fund for redistribution.

#### **LEASES**

Leases that do not transfer substantially all the risks and rewards incidental to ownership of an asset to Heritage New Zealand Pouhere Taonga are classified as operating leases.

Lease payments under an operating lease are recognised as an expense on a straight-line basis over the term of the lease in the Statement of Comprehensive Revenue and Expense.

#### **CASH AND CASH EQUIVALENTS**

Cash and cash equivalents include cash on hand, deposits held on call and other short-term, highly liquid investments, with original maturities of three months or less.

#### **DEBTORS AND OTHER RECEIVABLES**

Debtors and other receivables are recorded at amounts due less any provision for uncollectability.

Uncollectability is established when there is objective evidence that Heritage New Zealand Pouhere Taonga will not be able to collect amounts according to the original terms of the receivable. The amount of the provision is the difference between the carrying amount and the present value of the amounts expected to be collected.

#### **INVENTORIES**

Inventories held for commercial use are valued at the lower of cost or net realisable value cost after providing for obsolete items.

#### **PROPERTY, PLANT AND EQUIPMENT**

Property, plant and equipment comprises land, land development, buildings, leasehold improvements, heritage artefacts and equipment including library items, displays and interpretation, office furniture and equipment.

Property, plant and equipment are shown at cost or valuation, less any accumulated depreciation and impairment losses.

Heritage New Zealand Pouhere Taonga has recognised interests in land and buildings in the following categories:

i. Heritage New Zealand Pouhere Taonga owned land and historic buildings

These are properties for which the Heritage New Zealand Pouhere Taonga has freehold title.

ii. Vested land and historic buildings

These properties have been formally vested to Heritage New Zealand Pouhere Taonga in terms of the Reserves Act 1977. A vesting order can only be revoked with the agreement of Heritage New Zealand Pouhere Taonga and consequently its interest is deemed to be permanent.

iii. Controlled and managed buildings

These are properties for which Heritage New Zealand Pouhere Taonga has a control and management order from the Crown in terms of the Reserves Act 1977. These have been included as part of property, plant and equipment on the basis that the risks and rewards relating to this property rest with Heritage New Zealand Pouhere Taonga. However, the Crown can require Heritage New Zealand Pouhere Taonga to return these assets at any stage.

#### *Revaluations*

Heritage New Zealand Pouhere Taonga employs an independent valuer to revalue Heritage New Zealand Pouhere Taonga's property portfolio in line with the Crown accounting policies. Land and buildings are revalued every three years to ensure that the carrying amount does not differ materially from fair value.

Heritage collections and objects are by nature specialised and are managed by Heritage New Zealand Pouhere Taonga in accordance with its general statement of policy and as required by the Heritage New Zealand Pouhere Taonga Act. These items are revalued and measured on a fair market or replacement value but are not depreciated. A four-year rolling cycle is conducted by registered valuers specialising in art and objects.

<sup>22</sup> The Heritage New Zealand Pouhere Taonga portfolio comprises heritage properties with no or little potential occupant or buyer market and therefore an absence of market transactions. In accordance with the Valuation Guidance for Cultural and Heritage Assets prepared by the Treasury Accounting Policy Team, Depreciated Replacement Cost (Summation Approach) is deemed the most appropriate basis for determination of fair value, as fair value of the asset is not able to be reliably determined using market-based evidence due to the specialised or unique nature of the asset.

In the intervening years, enquiries are made of management and professional valuers to establish if there are any factors that may have given rise to significant changes in valuations.

#### **Accounting for revaluations**

Heritage New Zealand Pouhere Taonga accounts for revaluations of property, plant and equipment on a class of asset basis. The results of revaluing are credited or debited to an asset revaluation and recognised as other comprehensive revenue and expense. Where this results in a debit balance in the asset revaluation reserve, this balance is expensed. Any subsequent increase on revaluation that off-sets a previous decrease in value is recognised as part of the net surplus for the year, up to the amount previously expensed, and then credited to the revaluation reserve for that class of asset and shown as part of other comprehensive revenue and expense.

#### **Additions**

The cost of property, plant and equipment is recognised as an asset when it is probable that associated future economic benefits or service potential will flow to Heritage New Zealand Pouhere Taonga and the cost can be measured reliably.

#### **Subsequent costs**

Subsequent costs incurred by Heritage New Zealand Pouhere Taonga to restore property and plant to their original condition are capitalised. Expenditure to maintain these assets once renovation is complete is recognised in net surplus when incurred.

#### **Disposals**

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount of the asset. Gains and losses on disposal are included in the net surplus for the year. When revalued assets are sold, the amounts included in the revaluation reserves in respect of those assets are transferred to accumulated funds.

#### **Depreciation**

Depreciation is provided on a straight-line basis on all property, plant and equipment (other than land, heritage artefacts and library), at a rate that will write off the cost (or valuation) of the assets to their estimated residual value over their useful lives.

The useful lives and associated depreciation rates of major classes of assets have been estimated as follows. Heritage buildings owned, vested or managed in Heritage New Zealand Pouhere Taonga are depreciated in accordance with PBE IPSAS 17.

Buildings	100 years
Land Development	7-15 years
Plant and Equipment	3-10 years
Displays & Interpretation	10 years
Other Assets	5 years

The residual value and useful life of an asset is reviewed, and adjusted, if applicable, at each financial year-end.

#### **Impairment**

Property, plant and equipment and intangible assets that have a finite useful life are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For assets not carried at a revalued amount, the total impairment loss is recognised in the net surplus or deficit for the year.

If an asset's carrying amount exceeds its recoverable amount the carrying amount is written down to the recoverable amount and an impairment loss is recognised. For revalued assets the impairment loss is recognised against the revaluation reserve for that class of

asset. Where that results in a debit balance in the revaluation reserve, the balance is recognised in the net surplus or deficit for the year.

Value in use is the depreciated replacement cost for an asset where the future economic benefits or service potential of the asset are not primarily dependent on the asset's ability to generate net cash inflows and where Heritage New Zealand Pouhere Taonga would, if deprived of the asset, replace its remaining future economic benefits or service potential.

#### **CREDITORS AND OTHER PAYABLES**

Short-term payables are recorded at the amount payable.

#### **EMPLOYEE ENTITLEMENTS**

##### ***Short-term employee entitlements***

Employee entitlements that Heritage New Zealand Pouhere Taonga expects to be settled within 12 months of balance date are measured at undiscounted nominal values based on accrued entitlements at current rates of pay.

These include salaries and wages accrued up to balance date, annual leave earned but not yet taken at balance date, retiring and long service leave entitlements expected to be settled within 12 months and sick leave. Heritage New Zealand Pouhere Taonga also recognises a liability and an expense for bonuses where it is contractually obliged to pay them, or where there is a past practice that has created a constructive obligation.

#### **Long-term employee entitlements**

Entitlements that are payable beyond 12 months, such as long service leave and retirement leave, have been calculated on an actuarial basis. The calculations are based on the likely future entitlements accruing to staff, based on years of service, years to entitlement, the likelihood that staff will reach the point of entitlement and contractual entitlement information.

The value of the long service leave obligations depends on a number of factors that are determined on an actuarial basis using a number of assumptions. Due to the small size of the provision, no salary inflation factor has been allowed.

#### **COMMITMENTS**

Future payments are disclosed as commitments at the point a contractual obligation arises, to the extent that there are equally unperformed obligations.

#### **CONTINGENCIES**

Contingent liabilities and assets are disclosed at the point at which the contingency is evident.

#### **CHANGES IN ACCOUNTING POLICIES**

There are no changes in accounting policies.
